GCA SCHOOL BUS CONTRACT 2018-2019

Although, parents pay for their child(ren) to ride the school bus, the GCA administration considers this a **privilege.** Therefore, all students who ride the school bus will conduct themselves in a manner that is safe and respectful of self and others. **All** GCA Standards of Excellence that apply on the school campus and when a student is in GCA uniform apply when that student is on the bus. Parents of students who ride the school bus are responsible for their child (ren)'s conduct on the way to and from school and at each bus stop.

Students will maintain the following expectations:

- There is no eating and drinking on the school bus so that the bus is clean.
- For the safety of the child, other bus-riders, the bus-driver and others, students will remain in their seats (pre arranged seats) once they have boarded the bus and until they arrive at their destination.
- Uphold all the GCA Standards of Excellence.

All and any unacceptable / inappropriate conduct on school transportation leads to disciplinary action.

Consequences: Phased-in based on response and repetition of inappropriate conduct.

- A verbal warning that is reported to parents.
- A written warning on the student file.
- One day suspension from school transportation.
- Permanent loss of privilege to ride school transportation.
